- e) Mr. Cusano (resident) stated Joe Allen said his road is being taking care of but he would like something for the dust.

- i) Claude (fire dept.) stated new ambulance on track. Claude discussed Medicount payments going to us that were Sheffield Lake. Refund to Medicount around \$15,000 to 16,000.
- j) Dale (resident) asked for the trustees to pass a resolution regarding no cemetery sales west of the cemetery bldg. <u>Kenny made a resolution only</u> sell plots east of the bldg. in the cemetery. No sales west of the bldg. Troy 2<sup>nd</sup>. All in favor. Resolution # 44.
- **k**) Gary Weir (non-resident) discussed the area just west that was ditched. He asked whose responsibility is it. Kenny said either the state or the property owner responsibility.

- **r**) Alan (trustee) Thanked Dawn and Mark for taking care of selling a plot in the cemetery. Alan said the roads are looking good. Alan also said a resident said they also saw a bear in the area
- s) Troy (trustee) stated we need brine on Pine Lake on Fridays if we can unless raining. Troy discussed earlier the Land Conservation Easement.
- t) Ken (chairman.) stated he spoke with Mr. Waldron and got his deed back, he also is trying to get ahold of Mr. & Mrs. Ernst regarding the cemetery deeds. He also has left messages for Michael Ollia regarding his deed also. Kenny also asked about advertising for the fire chief Dawn said we have been getting questions regarding pay and job duties. There was discussion on the fire dept. chief job description. The trustees agreed to change the wording on the job description from required to recommended. <u>Resolution # 46 Alan made a motion to accept the fire chief job description with the changes of recommended requirements and the following are recommended for the position of the Sheffield Fire dept. fire chief, Troy 2<sup>nd</sup> all in favor.</u>
