- g) Tracy Kohta (Fiscal Officer) Discussed an email received concerning putting a drug addiction website on township website. Trustees feel is someone is looking for help, they will look for a treatment center not at a township website. Tracy received a price increase of \$37 for the bronze plaques from Haines Memorial. Alan made a motion to raise the plaque charges for the cemetery monument to \$775 plus the \$100 township fee. Troy 2nd. All in Favor. Resolution #10 Tracy discussed that the township did not receive the schedule B from the county to complete the revenue budget. Tracy entered the appropriations discussed at the last meeting that were able to be entered without going over the carryover fund amounts.

Alan made a motion to approve purchase orders blanket purchase orders 1-2023 to 22-2023 for general utilities: electric, phone, office supplies, waste management, repairs & maintenance for road & fire depts., general expense, tower rental, pump testing, hose & ladder testing. Ken 2nd, All in Favor. Resolution #11

Discussed employee evaluations with Claude Kobernik and potential raise in executive session.

Ken made a motion to raise the Fire Chief's pay to \$500 starting in February. Troy 2nd. All in Favor. Resolution #12 Claude thanked the trustees for the raise. He also asked the trustees to all help with the talks with Monroe to continue to move this process forward. Trustees also discussed emergency purchases for fire and road depts. With having open purchase orders for the fire dept., Claude will inform one trustee of the emergency.
