- m) Dean (zoning) gave (1) permit house, (2) garage permits. Dean stated a resident thanked him for not giving him a permit because the aerial shot was incorrect.
- n) Dave (Fire Chief) stated we didn't receive grant money for the one grant. Dave said we need to order new turn out gear for outdated gear and new fireman. Cost is about \$2500.00 would like a quantity of (10). Dave asked about using the building out back for fire training. (1) Person would like to take the (36) hr. fire training. Trustees agreed. Training for Joe Janson went down need to reissue a new check for \$350.00. New doors are sticking in the fire dept. need checked. Alan to contact Weather Sealco regarding doors.

- Dave stated we have (2) Paramedics, (4) Emts and First Responders lined up to help respond for Sheffield Fire Dept.
- o) Barb (fire dept.) stated training grant money for 2013 was given.
- p) Troy (trustee) inquired who is going to Sunshine Law training on May 12.

  Troy asked about our liability on drug screening Dawn stated she emailed the prosecutor on this issue. Troy drove roads ok. Resolution #35 Troy made a motion to go into executive session for personnel matters @ 7:10 pm, Ken 2<sup>nd</sup> all in favor. Troy made a motion to return to regular session @ 7:25, Ken 2<sup>nd</sup> all in favor. Alan stated a letter from the fire dept. was sent to the prosecutor, the prosecutor has requested a meeting with a Trustee and our Fiscal Officer.
- q) Ken (trustee) stated he went to meet with the county engineer about the property on Van Slyke Rd., he recommended a minimum of 42" pipe, property owner to check into this. The county said we can make a resolution to change speed limit for unimproved roads. All our roads are considered unimproved. The county will still study Maple Rd. Ken suggested topsoil for the cemetery. Resolution # 36 Ken made a motion for (2) loads of topsoil to fill and clean-up cemetery. Kenny asked for clean-up day to be put on the sign.
- r) Alan (chairman) stated at the last meeting there was complaint about garbage and a barking dog. Alan spoke with previous owner, he said the new owner has paid for the property in full but hasn't paid for closing cost and transferred the title out of his name. Alan said the previous owner does not have anything to do with it anymore. Alan said we need to work on our Memorial Day lineup. We usually start Memorial Day @ 9:00 am. We still need a speaker. Alan stated he drove the roads, still soft spots. Alan stated on the ambulance issue we are not voting on until we speak with the prosecutor.
